



SESSION SUMMARY

Actions taken by the Session at its quarterly meeting, Tuesday, May 11, 2021.

1. Approved the draft Fiscal Year 2022 budget, recommended by the Board of Deacons, to be presented at the June Congregational meeting (our Fiscal Year starts July 1). After presentation to and discussion by our members, the Session will vote to approve the final budget.
2. Expressed gratitude for the extensive work of outgoing Chair of the Board of Deacons, Mr. Chris McPeek.
3. Recommended to Presbytery to take pastoral intern Austin Kettle under care as he continues to develop the ministerial call on his life.
4. Authorized the beginning of the process to establish the next multi-site location in Reston and assigned TE J.T. Tarter as the site pastor for the campus.
5. Approved entering the next phase of our Regathering Plan subject to the anticipated relief from the current Virginia Executive Order related to group gatherings. This will allow us to fully regather for unlimited-capacity worship (no RSVPs) and begin planning for more in person gatherings in the new few weeks and months for all our ministries.
